Many people are frightened about the possibility that nuclear warfare might destroy mankind. The truth is that alcoholism is a more immediate hazard to humanity than the atomic bomb.

The insidious effects of social drinking are destroying human bodies, souls, homes and busineses here and now.

Lesson on Values

"The average pay of manufacturing production workers in the Oklahoma City area in April rose to \$8.77 ay hour. ..." Thus reads an ar-ticle in The Daily Oklahoman June 6, 1982, by Glen Bayless. The article goes on to point out that there are many who are paid more than this — and some who are paid less. I am writing in response to this article because I have a personal interest involved. I happen to have a family member who is presently teaching summer school classes in one of the metropolitan districts (public schools). She has a master's degree in liberal arts, lacks only her dissertation on her doctor's degree (which means she has invested more than seven years in 'higher" learning beyond high school), is a superior "born" type teacher, works hard at the job (meaning that she spends many hours outside the classroom in planning, grading papers, doing essential 'home-work," and sponsoring "extracurricular" actitivies), and gives herself without reservation to her teaching opportunity.

For all the special" activities and homework she gets no pay. For actual hours spent in the classroom she gets \$125 per week. If you would figure the total work time essential to her success as a teacher you would find that she is being paid less than the legal minimum wage for any kind of work — actually, less than teen-agers get per hour for part-time work.
