Pro-Left Educators Vs. the New Right

THE National Education Association was perceived for a long time as an organization for professional improvement of its members. In recent years, it has become established as a labor union and it is becoming a major influence in the political arena.

A pamphlet which has reached this desk reveals where NEA stands politically, socially, morally and otherwise. Titled "Combatting the New Right," the 50-page "Participant's Manual" is identified as "A Training Program Developed by Western States Regional Staff, National Education Association."

Informed sources say conferences using this material were held at Lawton, Putnam City and elsewhere in Oklahoma this summer.

"What is emerging today is a powerful convergence of forces on the right — militant cold warriors, anti-education would-be censors, anti-union, anti-regulatory free enterprise boosters, so-called pro-life, pro-family and pro-flag superpatriots, and

cians," the pamphlet says in accusing "right wing extremists" of exploiting emotional issues.

'If that is the "right wing" and NEA is against it, where does that put NEA? Somewhere out in left field?

A half dozen pages are taken up with brief listings of "New Right," pro-business, patriotic, conservative and Christian organizations that NEA and OEA apparently consider to be their enemies.

One of the writers asserts that the "New Right" does not come close to traditional conservative philosophies but she does not imply adherence to those principles by NEA.

Instead, she declares that the "New Right" is peddling an old ideology that "is not new any more than it is right." This she says includes a belief in rugged individualism, a placing of property values over human values, a conviction that poor people are poor through fault of their own, a general anti-intellectualism, and fixed adherence

thoritarian control system.

Academic freedom is discussed as being "high on the hit list of the New Right." It is asserted that censorship battles are "the result of haphazard fanaticism on the part of a few crazy, disorganized fanatics."

Is that how NEA regards parents who object to their children being required to read profane, obscene or pornographic textbooks?

The pamphlet cites a definition of "Academic Freedom" by the American Library Association staff, which says: "Academic freedom requires recognition that even ideas which are generally deemed offensive, spurious, frivolous, or even dangerous to institutions, beliefs and objectivities are worth protecting — if only for the context they provide."

The pamphlet indicates that the "Right" is wrong when it opposes "values clarification" or favors prayers in schools, favors getting "the government off our backs," wants to "deny civil rights on the basis of sexual orientation" (homesexualism), or supports free enterprise.
